***SECOND ORDER AMENDING NOTICE TO PARTIES & INVITATION

On January 8, 2004, the Commission issued a Notice to Parties & Invitation to Interested *Amicus Curiae* to File Supplemental Briefs. On February 10, 2004, the Commission extended the due date for interested *amici curiae* to file briefs to March 24, 2003.
